All applicants planning to be in F-1 status are required to complete this form and provide financial supporting documents to demonstrate their ability to pay all tuition, fees and living expenses for the first year of their academic program. An I-20 Certificate of Eligibility will be issued to the student once admitted to the University and financial documents have been verified.

#### FINANCIAL DOCUMENTATION

Financial documents that demonstrate proof of funding must:

- Be in English or be accompanied by a certified English translation
- Be on official bank letterhead, with bank stamp or bank officer's signature
- Show minimum funding required for one academic year and include type of currency
- Include an issue date that is no earlier than June 1 for Spring applications and October 1 for Fall applications.
- Include the account holder's name (if account not in student's name, then name on financial document must match name
  of sponsor in Sponsor Agreement section of Financial Affidavit Form)

#### ACCEPTABLE DOCUMENTS

- Bank Letters
- Bank Statements (from Saving or Checking Accounts)
- Fixed/Term/Time Deposits Must be able to be withdrawn at any time without penalty
- Loan Letters
- Scholarship Letters (Government, Private or School)
